## TALKING POINTS: 2024 NAFIS SPRING CONFERENCE

### Impact Aid Overview

Through Impact Aid, the Federal Government seeks to compensate school districts for lost property tax revenue arising from the presence of nontaxable Federal property (i.e. military installations, Indian trust and treaty lands, Federal low-rent housing, national laboratories and grasslands, and other Federal lands) within school district boundaries. Funding appropriated annually by Congress goes directly to school districts and can be used for any general fund purpose, including staff, mental health supports, technology, and transportation, supporting all students. This flexibility allows school district leaders to target funds based on need. While this program’s funds are immensely helpful to school districts, it has not been fully funded in decades.

### Annual Federal Funding

**FY 2025 Appropriations** – With schools facing many challenges, including the need to build or renovate facilities, attract and retain educators, and adjust to recent education cuts, Impact Aid dollars are more precious now than they have ever been. Therefore, we are requesting a \$65 million increase for Basic Support, a \$2 million increase for Federal Property, a \$1.5 million increase for Construction, and a \$1.5 increase for Children with Disabilities.

### Talking Points on Impact Aid Funding:

- **REQUEST** support for a \$70 million increase for Impact Aid in FY 2025:
  - \$65 million increase for Basic Support
  - \$2 million increase for Federal Property

  - \$1.5 million increase for Children with Disabilities

### **Advancing Toward Impact Aid Full Funding Act**

**Background:** The Federal Government has a responsibility to fully fund Impact Aid, but it has not met this responsibility since 1969. This legislation would establish a five-year glidepath to full funding and ensure meaningful annual increases to districts.

The NAFIS-endorsed and fully bipartisan *Advancing Toward Impact Aid Full Funding Act* has now been introduced in the House (H.R. 1591) and the Senate (S. 871). This legislation would fully fund Basic Support and provide a proportional increase to Federal Property, Construction, and Children with Disabilities.

### **Impact Aid Infrastructure Partnership Act**

**Background:** The current Impact Aid Construction line provides only \$18.41 million annually, which is insufficient to meet most internal renovation needs and provides no funding to build new schools. There is also a significant demand for funding to renovate and construct teacher housing.

The *Impact Aid Infrastructure Partnership Act*, which would add a total of \$1 billion over four years (\$250 million per year) to the Impact Aid Construction line item, has been introduced in the House (H.R. 6698) and the Senate (S. 2808). 25% of the new funds would be made available via formula to all eligible school districts. The U.S. Department of Education would disseminate the remaining 75% as competitive grants, with priority for those school districts with acute emergencies in their facilities (e.g., building code violations), teacher housing in need of repair, or limited or no bonding capacity.

There are more than 100 current Members of Congress on the coalitions. We hope to continue to grow these numbers and have the largest coalitions yet by the end of the 118<sup>th</sup> Congress. ## Spring MISA Breakfast Meeting

The spring breakfast meeting for 2024 was held in conjunction with the NAFIS spring conference on March 11. **Kyle Fairbairn**, MISA Executive Director, welcomed attendees and noted that today's meeting highlights several special guests. The meeting began with Waynesville R-VI School District, MO Color Guard Presentation of Colors and the Pledge of Allegiance. Fairbairn then awarded plaques to several long-time MISA friends -- Mark Vollmer – Superintendent, Minot AFB SD #160, MISA Executive Member; James Rostad, School Board Member Minot AFB SD, #160; and Lynn Watkins – National Association of Federally Impacted Schools (NAFIS) Director, Operations & Conference Services.



**Keith Mispagel**, MISA Executive Board President, welcomed the attendees and introduced the members of the MISA Executive Board and asked attendees to introduce themselves. **Keith Mispagel** and **John Erickson**, Hawaii Public Schools, introduced our guest speaker, **Sharene Brown**, Spouse of the Chairman of the Joint Chiefs of Staff (CJCS). **Helen Payne**, Superintendent, North Hanover Township Schools, asked questions of Ms. Brown. Through her responses, Ms. Brown emphasized how school districts and installations can better work together



to provide the best educational experiences for military families. She noted that relationships between parents, students and school personnel is one of the most important factors to a successful experience. Through examples, she described how taking care of students as individuals is key to success. When asked about the topic of special education services, Ms. Brown implored school personnel to use data to explain special education services and resources. She pointed out that School Liaison Officers can also be extremely useful as a connection to informing parents about available services and resources. She explained that military families need to get involved in school districts to foster relationships. She complimented sharing best practices among school districts serving military families. Lastly, Ms. Brown emphasized that military-connected students want to be just like everyone else and “fit in.”

**Kyle Fairbairn** introduced **Hilary Bales**, Superintendent of Waynesville SD, who led a discussion of the Waynesville students who were visiting DC with the district officials. The students' discussion centered on the topics of transition issues and ideas to improve. Each student highlighted challenges that they faced as they transitioned to new districts. Those challenges included: getting into colleges of choice; credits for promotion; moving away from friends; and connections with faculty. They also listed things that have proved to be of benefit to them as they transitioned. Those included: joining JROTC; participation in extra-curricular activities; acceptance into leadership positions within school activities; career education offerings; and involved teachers who took time to get to know them and their needs.



### The following partners spoke to the group:

- **Kathy Facon**, DoDEA, gave an update on the administration of the Impact Aid for CWSD including the need for more districts to apply for funding and a possible look at how the formula might need to change. She explained issues related to Source Check and the importance of the installation's involvement in supplying data. She reminded the group about the grants program through DoDEA.
- **David Kennedy**, Office of Local Defense Community Cooperation - Public School on Military Installations, shared the latest on projects that are underway and upcoming projects.
- **Dr. Ernise Singleton**, MIC3 Commission Chairwomen & **Cherise Imai**, Executive Director, MIC3, provided a review of the annual business meeting including the addition of Blue Star Families as an Ex Officio Member. Cherise Imai briefed the group on the MISA/MIC3 partnership that will once again offer training at the local school district level.
- **Kyle Fairbairn** reviewed the cards for Capitol Hill visits, reminded attendees of the MISA Scholarship offering and highlighted the upcoming summer meeting in Savannah, GA.

AGREEMENT BETWEEN

FRESNO PACIFIC UNIVERSITY  
DIVISION OF TEACHER EDUCATION & SPECIAL EDUCATION  
&  
Central Union School District  
Lemoore, California

THIS AGREEMENT entered into on 03-06-2024 by and between Fresno Pacific University, hereinafter called the University, and Central Union School District, in Lemoore, California hereinafter called the District.

It is mutually agreed between the parties hereto, as follows:

The intent of this memorandum of understanding (MOU) is to clarify the roles and responsibilities of the University and the District with respect to collaboratively supporting Student Teachers pursuing a Multiple Subject, Single Subject, Mild Moderate Support Needs, Extensive Support Needs, or Early Childhood Special Education Preliminary Teaching Credential.

“Student Teaching” as used herein and elsewhere in this MOU, refers to the active participation in the duties and functions of classroom teaching under the direct supervision and instruction of employees of the University and employees of the District who hold valid credentials issued by the Commission on Teacher Credentialing (CTC) authorizing them to serve as classroom teachers in the school in which the Student Teaching is provided.

**I.**

**The University and the Participating District will:**

- A. The program’s organized coursework and clinical practice provide multiple opportunities for candidates to learn, apply, and reflect on each Teaching Performance Expectation (TPE). As candidates progress through the curriculum, faculty and other qualified supervisors assess candidates’ pedagogical performance in relation to the TPEs and provide formative and timely performance feedback regarding candidates’ progress toward mastering the TPEs.
- B. The program’s Clinical Practice experiences are designed to provide the candidate with a developmental and sequential set of activities that are integrated with the program’s coursework and extend the candidate’s learning through application of theory to practice with PreK-12 students in California public school classrooms.
- C. Support the selection of clinical sites (schools) that demonstrate commitment to collaborative evidence-based practices and continuous program improvement, have partnerships with appropriate other educational, social, and community entities that support teaching and learning, place students with disabilities in the Least Restrictive Environment (LRE), provide robust programs and support for English learners, reflect to the extent possible socioeconomic and cultural diversity. Clinical sites should also have a fully qualified site administrator.
- D. Support the selection of clinical sites (schools) for Educational Specialist Student Teachers that demonstrate the full diversity of grades/ages, federal disability categories and the continuum of special education services outlined in the specific credential authorization.
- E. Facilitate the selection of Mentor Teachers for all Student Teachers. Mentor Teachers must hold a Clear Credential in the content area for which they are providing support to the Student Teacher



and have a minimum of three years of content area PreK-12 teaching experience. The District/Site Support Provider must have demonstrated exemplary teaching practices as determined by the district.

- F. Ensure the Student Teacher can record their teaching with PreK-12 students and that the school or district where the Student Teacher is placed has an adopted recording policy.

**The Participating District will:**

- A. Provide Student Teachers with adequate time in the classroom and support to complete student teaching requirements as defined by their credential program.
- B. Ensure the assigned Mentor Teacher has adequate time to provide five hours (average) per week of support and guidance to the Student Teacher.
- C. Be able to, after consultation with the University, refuse to continue student teaching placement for Student Teachers who are not performing satisfactorily.

**The University will:**

- A. Provide Student Teachers with sufficient guidance and support to meet the requirements of their credential programs.
- B. Select and assign university mentors who are credentialed or who have equivalent experience in educator preparation. University mentors should be experts in the content area of the Intern being supported and should have recent professional experiences in school settings where the curriculum aligns with California's adopted content standards and frameworks and the school reflects the diversity of California's student population.
- C. Provide university mentors with an orientation to the program's expectations and ensure that mentors are knowledgeable about the program curriculum and assessments, including the Teaching Performance Expectations (TPE) and the California Teaching Performance Assessment (CalTPA). In addition, mentors will maintain current knowledge of effective supervision approaches such as (but not limited to) cognitive coaching, adult learning theory, and current content-specific pedagogy, and instructional practices.
- D. Confirm that a Mentor Teacher has been assigned and ensure they remain current in the knowledge and skills for candidate supervision and program expectations. The professional development training topics include (but are not limited to) an initial orientation to the program curriculum, effective supervision approaches such as cognitive coaching, adult learning theory, current content-specific pedagogy, and instructional practices.
- E. Compensate the Mentor Teacher in the form of a tuition waiver (1 unit per semester when supporting an Initial Student Teacher and 3 units per semester when supporting a Final Student Teacher). Tuition Waivers can be used towards either graduate or professional development coursework at the University.
- F. Communicate to the District, at the beginning of each fall and spring semester, a disclosure of the student teacher(s) supported by the University and the University Mentor providing support to the student teacher(s).

**The Student Teacher will:**

- A. Meet all requirements as outlined by their credential program to qualify to serve as Student Teacher.
- B. Meet the legal, ethical, and other professional standards expected of Student Teachers.

- C. Prioritize course and student teaching attendance and completion of other credential program requirements.
- D. Demonstrate teaching competency as defined in the TPEs and evaluated through the program's assessment system.

## II.

Worker's Compensation Coverage. Practicum students are volunteers of the District and not entitled to the District's Worker's Compensation coverage. The University will provide Worker's Compensation coverage to practicum students for injury or disease arising out of their use of the District's facility while participating in the University's program.

Interns who are contracted employees of the District will be covered by the District's Worker's Compensation coverage.

Liability Insurance. University and the District shall maintain in full force and effect, at all times during the term of this Agreement, the following liability insurance:

1. Commercial General Liability Insurance including, but not limited to, personal injury (including bodily injury and death), and property damage for liability arising out of each of their intern/practicum student's performance under the Agreement. Coverage shall include Abuse or Molestation Liability. Said insurance coverage shall be no less than ONE MILLION DOLLARS (\$1,000,000) per occurrence and THREE MILLION DOLLARS (\$3,000,000) aggregate.
2. Professional Liability (Errors and Omissions) Insurance for liability arising out of, or in connection with, each of their intern/practicum student's performance under this Agreement. Coverage shall be no less than ONE MILLION DOLLARS (\$1,000,000) per each wrongful act or offense and THREE MILLION DOLLARS (\$3,000,000) aggregate.

At the request of the District, the University shall deliver all required certificates of insurance to the District. The certificates shall make reference to all provisions and endorsements referred to in this section and shall be signed on behalf of the insurer by its authorized representative.

## III.

This assignment of a student of the University to Internship and practicum experiences in the District shall be deemed to be effective for the purposes of this Agreement as of the date the student presents to the proper authorities of the University the preliminary Certificate of Clearance (or other state-mandated clearance) and to the District the assignment sheet issued by the University.

## IV.

Each party shall be responsible for the negligence of its own employees. Liability is limited by the California Commission on Teaching Credentialing and all other applicable laws. For purposes of this paragraph, the actions of an Intern or practicum student, while acting within the legitimate scope of their authority, shall be deemed to be the actions of the University.

## V.

Discrimination Clause: The University and the District agree to abide by the requirements of the following as applicable: Title VI of the Civil Rights Act of 1964 and Title VII of the Civil Rights Act of 1964, as amended by the Equal Employment Opportunity Act of 1972, Federal Executive Order 11246 as amended, the Rehabilitation Act of 1973, as amended, the Vietnam Era Veteran's Readjustment

Assistance Act of 1974, Title IX of the Education Amendments of 1972, the Age Discrimination Act of 1975, and the Fair Housing Act of 1968 as amended; and the District agrees to abide by the requirements of the Americans with Disabilities Act of 1990.

The University and the District agree not to discriminate in their respective employment practices and will render services under this contract without regard to age, race, color, religion, sex, sexual orientation, national origin, veteran status, political affiliation, or disabilities. Any act of discrimination committed by the University or the District or failure to comply with these statutory obligations when applicable shall be grounds for termination of this contract.

Non-Discrimination: District agrees to: (1) immediately report to the University's Title IX Coordinator any allegation that a student of Fresno Pacific University has been discriminated against or harassed, or that the student has discriminated or harassed others; and (2) to cooperate with investigation and adjudication procedures in the Unlawful Discrimination/Harassment Policy & Procedures, as those they may change from time to time.

## VI.

### HIPAA and HITECH

1. To the extent that District is a facility that is subject to the federal Health Insurance Portability and Accountability Act of 1996 ("HIPAA") and the Health Information Technology for Economic and Clinical Health Act ("HITECH"), the Parties agree as set forth below in this section 8. If District is not Subject to HIPAA and/or HITECH, then this section shall not apply.
  - a. Compliance at Site. That University's students and faculty are part of District's workforce for purposes of HIPAA and HITECH only when at the District. Accordingly, all faculty and students of University must comply with the District's policies and procedures regarding the use, disclosure or creation of protected health information ("PHI") or electronic protected health information ("E PHI").
  - b. Training in HIPAA and HITECH Compliance. University shall provide appropriate general training to its students regarding the requirements for the security and privacy of PHI and E PHI under HIPAA and HITECH, including the survivability of these requirements after the internship concludes. Students shall receive such training prior to their placement at the District. Faculty and students shall also complete any additional training regarding PHI and E PHI required by the District's policies and procedures, as those policies and procedures may change from time to time.
  - c. Use of PHI and E PHI Outside Site Prohibited. The Parties agree that students assigned to the District will not utilize PHI or E PHI outside of District. Students are prohibited from removing PHI or E PHI from the District's records. Use of PHI or E PHI in the classroom or for research purposes is not permitted. No PHI or E PHI accessed at District will be received, used, stored, transmitted or maintained by University. Any such use will subject the student to discipline under University's applicable procedures and is grounds for removal of the student from participation in the internship with the District.
  - d. Notice Required If PHI or E PHI Has Been Breached. The Parties agree to notify each other in writing as soon as practicable and in all events no later than 48 hours after either Party obtains knowledge that PHI or E PHI has been used, disclosed, transmitted or otherwise accessed in violation of HIPAA and HITECH.

## VII.

### Indemnification:

1. University agrees to indemnify, defend, and hold harmless the District and its affiliates, directors, trustees, officers, agents, and employees, against all claims, demands, damages, costs, and expenses of whatever nature, including court costs and reasonable attorney's fees, arising out of or resulting from the University's wrongful or negligent act or omissions in performing obligations under this MOU.
2. District agrees to indemnify, defend, and hold harmless University and its affiliates, directors, trustees, officers, agents, and employees, against all claims, demands, damages, costs, and expenses of whatever nature, including court costs and reasonable attorney's fees, arising out of or resulting from the District's wrongful or negligent acts or omissions in the performance of its obligations contemplated by this MOU.

## VIII.

This Agreement will remain in force until the University or District wishes to terminate the agreement. Notwithstanding anything herein contained to the contrary, this Agreement may be terminated and the provisions of this Agreement may be altered, changed, or amended by the mutual consent of the parties hereto.

### ADDITIONAL PROVISIONS

1. Nothing contained in this Agreement shall be deemed or construed to create a joint venture, partnership, principal-agent or employment relationship between the parties and neither party shall have the authority to bind the other party for any purpose.
2. This Agreement and the rights and obligations of the parties shall be governed and construed by the laws of the State of California. Any lawsuit concerning or arising out of this Agreement shall be venued in the county in which the LEA is located.
3. This Agreement supersedes all prior and contemporaneous agreements and understandings between the parties, both oral and written, with respect to its subject matter and constitutes the complete agreement and understanding between the parties, unless modified in a writing executed by both parties.
4. In the event of a dispute between the parties arising from this Agreement, the parties agree to mediate the dispute before initiating litigation. The Parties agree that with regard to any dispute or claim related to this Agreement, prior to the initiation of a lawsuit or other legal action, they shall and must, in good faith, submit the claim or dispute to mediation with any mutually agreeable neutral. The costs of the neutral will be split equally between the Parties. The prevailing party shall be entitled to recovery from the losing party the prevailing party's reasonable expenses (fees and costs) incurred in the lawsuit or legal action as allowed by law.
5. If any provision of this Agreement is determined to be invalid or unenforceable; that provision shall be amended to achieve as nearly as possible the same effect as the original provision, and the remainder of this Agreement shall remain in full force and effect.
6. No delay or failure by either party to act in the event of a breach or default hereunder shall be construed as a waiver of that or any succeeding breach or a waiver of the provision itself.
7. This Agreement may be executed in any number of counterparts, each of which shall be an original as against any party whose signature appears and all of which together shall constitute one and the same instrument.
8. There is no mentor stipend as part of this agreement.

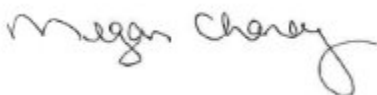

**MEMORANDUM OF UNDERSTANDING**

**Between**

**ALLIANT INTERNATIONAL UNIVERSITY, INC. A CALIFORNIA PUBLIC BENEFIT CORPORATION**

**And**

**CENTRAL UNION ELEMENTARY SCHOOL DISTRICT**

Alliant International University, Inc., a California Public Benefit Corporation (the "University"), and Central Union Elementary School District (the "District") agree to the following conditions that apply to Practicum Students, Student Teachers, and Teacher Interns (collectively, "Interns") who are or will be enrolled in the Teacher Credential Program, the MA/PPS: School Psychology Program or School Counseling Program through the California School of Education at Alliant International University and will be serving their Practicum or Internship in the District. Interns nominated by either the University or the District shall be mutually acceptable by both the University and the District, and shall be subject to a mutually acceptable placement within the District. This Memorandum of Understanding shall become effective August 01, 2024 for a period of three (3) calendar years. This Memorandum of Understanding may be terminated by either party with sixty (60) days' written notice, unless both parties agree to an earlier termination date. Any termination of the Memorandum of Understanding by either party shall not affect the status of any Intern who has been placed with the District prior to the effective date of termination.

**The University agrees and certifies that:**

1. Each Candidate shall have met the Basic Skills Requirement by way of California Basic Educational Skill Test (CBEST) or other exam option, coursework option, or combination option and, for Student Teachers and Teacher Interns, required subject matter competency is required prior to Clinical Practice clearance for Student Teachers (Clinical Practice III) or Intern (Clinical Practice I).
2. Each Candidate shall possess a minimum of a Bachelor's Degree, documented by official transcripts with a minimum overall GPA of 2.5. Candidates must have a minimum of 3.0 GPA to be recommended for a credential (Intern, Preliminary, or Clear).
3. Each Teacher Intern shall have a minimum of 120 hours of verified pre-service experience with students in educational settings. Each School Psychology Intern shall have a minimum of 450 hours of verified Practicum Experience and 1200 hours of Culminating Field Experience or Internship, and each School Counseling Intern shall have a minimum of 100 hours of verified Practicum Experience and 800 hours of Culminating Field Experience or Internship.
4. Each Teacher Intern and/ or Student Teacher candidate shall have passed U.S. Constitution coursework or examination.
5. Each Candidate shall be provided adequate supervision, advice, encouragement and support, as appropriate, by University personnel, including but not limited to the University faculty and the University field supervisor as directed by the California Commission on Teacher Credentialing Standards.

6. University Supervisors will observe and evaluate Teacher Interns via the AMS at least three (3) times during an 8-week term and provide annotated feedback via the AMS for the video observation(s).
7. Alliant Personnel will correspond with District Employed Supervisors, District Support Providers (Interns) and Cooperating Teachers (Student Teachers) at the beginning of the Candidate's field experience in order to support the Candidate.
8. For Teacher Education programs, District Support Providers will be required to provide support and guidance an average 5 hours per week documented using Alliant's matrix/tool as aligned with the Teacher Performance Expectations (TPE) established by the Commission on Teacher Credentialing (CTC).
9. The University agrees to pay a stipend to Cooperating Teachers for Student Teachers in the amount of \$175 per 8-week term.
10. The University understands that all Student Teacher Candidates, Interns, and PPS Candidates are required to adhere to all state and local health orders.
11. If the University finds that an Intern performs below standards acceptable to the University, after appropriate support and advice have been exhausted and the Intern has been withdrawn from the program, the University is to provide immediate written notification to the District.

### **FINGERPRINT**

The University shall comply with the requirements of California Education Code Section 45125.1, and perform the following acts:

- A. Require all students and employees of University who may enter a school site during the time that pupils are present to submit their fingerprints in a manner authorized by the California Department of Justice (the "CDOJ");
- B. Prohibit students and employees of University from coming into contact with pupils until the CDOJ has ascertained that the student or employee has not been convicted of a felony as defined in California Education Code Section 45122.1;
- C. Certify in writing to the District that neither University nor any of University's employees or students who may enter a school site during the time that pupils are present have been convicted of a felony as defined in California Education Code Section 45122.1 and provide such certification to the District administrator for this contract; and
- D. Provide a list of the names of University's students and employees who may have contact with pupils to the District administrator for this contract. This list shall be updated for student and employee changes and shall list students and employees by appropriate school site.
- E. The District may require the University and its students who may have contact with pupils to submit to additional background checks at the District's sole and absolute discretion

### **TB CLEARANCE**

University certifies that all personnel providing services to students of the District are adequately screened so as to prevent the assignment of personnel who may pose a threat to the safety and welfare of students and that such personnel shall provide evidence of freedom from tuberculosis within the past sixty (60) days before starting service at the school site. TB Clearance is required at the point of Clinical Practice I clearance for California Student Teachers and Arizona Alternative Educators.

### **The District agrees and certifies that:**

1. The purpose of the Internship Program is to add to the pool of qualified teachers, school psychologists, or school counselors that the District has continually sought to maintain.

2. The District and the University, in partnership, will ensure School Counseling candidates meet with their supervisor for one (1) hour of individual or one-and-one half (1.5) hours of small group (limited 8 candidates per group) supervision per week.
3. The District and the University, in partnership, will ensure that Site Supervisors for School Counselors meet the following qualifications: (1) Possession of a valid PPS School Counselor Credential (2) Minimum of two (2) years PPS experience as appropriate to the candidate's fieldwork setting. (3) The supervisor is responsible to undergo training in models of supervision, the SCPEs, and program fieldwork requirements and share responsibility for the quality of field experience, design of field experiences, quality of clinical progress, and assessment and verification of candidate competence.
4. The District and the University, in partnership, will ensure that the Site Supervisors for School Psychologists meet the following qualifications: (1) Possession of a PPS School Psychologist Credential (2) Minimum of three (3) years of experience as professional in the field. (3) Knowledge of context and content appropriate to the practicum experience.
5. The Intern's services shall meet the instructional or service needs of the District.
6. The District and Student Teacher or Intern agree to provide quality educational experience to their students through in-person learning environments. Online schools, independent study programs, and home schools are prohibited as placements for Interns. When candidates are teaching at online schools, independent study programs, or home schools, the required experience may be challenging and, in some cases, impossible to achieve. Program must consider if the employment setting is appropriate for learning to teach and if the program will ensure that the Interns, Student Teachers, PPS candidates can get the significant experiences required to complete their course work in their programs. This includes the ability to teach whole groups of students. Decisions regarding fieldwork placements, including placements as a teacher of record, are the responsibility of the program, not the candidate nor the employer.
7. The District and Student Teacher or Intern understand they will be requested to use Video Progress Assessments, Teacher Candidates are required to show their ability to conduct a lesson to, at minimum, a small group of at least 4 students.
8. Each Intern shall be assigned as an Intern/Teacher of Record under a contract with an appointment of at least .60 FTE of their workday, and placed in a job that shall allow for substantial experience in instructional or service duties.
9. No appointment shall be made unless the prospective Intern provides proof of fingerprint clearance of a criminal background check or a photocopy of a California teaching permit, and verification that they are free from tuberculosis.
10. No Intern shall displace any fully credentialed employee in the District.
11. Each Intern shall be provided adequate supervision, advice, encouragement and support, as appropriate, by District personnel, including but not limited to both an immediate field supervisor and an in-district mentor as directed by the California Commission on Teacher Credentialing Standards.
12. The District and the University, in partnership, must provide support for each Alliant candidate.
13. For Teacher Education the District and University, in partnership, must provide a minimum of 189 hours annually of support for each teacher intern (45 hours of which will be dedicated to ELL support).



14. The Intern's salary shall not be reduced to pay for the supervision of the Intern.
15. The District/School agrees that Student Teacher Candidates shall not receive compensation for hours accrued during their Clinical Practice field experiences.
16. District Support Providers will correspond with Alliant Personnel at the beginning of the candidate's field experience in order to support the candidate.
17. The District Support Provider will support and provide guidance for an average of 5 hours per week as documented using Alliant's matrix/tool as aligned with the Teacher Performance Expectations (TPE) established by the Commission on Teacher Credentialing (CTC).
18. District Site Support Providers must hold credentials in the same exact areas as the Interns they support and/or hold a valid, clear California Administrative Services Credential.
19. All Intern Teachers and Student Teachers must have experience working with diverse student populations including English Language Learners (ELLs), students with disabilities, and students from varying socioeconomic statuses. For Clinical Practice placements, 10% of each area of the student population must be comprised of each of the following: ELLs, students with disabilities, and students from a low socioeconomic background. If a candidate is in a Clinical Practice placement that falls short of the 10% threshold in any of the aforementioned areas, the District understands that for each percentage point below that threshold, the candidate will be required to observe for two (2) full days in either an ELL classroom, a Special Education classroom, or a classroom at a Title 1 school, depending on the area or areas, of deficient diverse student population group(s), to gain sufficient experience in those student population groups.
20. District Support Providers for Interns, and Cooperating Teachers for Student Teachers must have a minimum of three (3) years' teaching experience, have a clear Credential in the credential area they are supervising (or a valid clear California Administrative Service Credential).
21. The program provides district-employed supervisors a minimum of 10 hours of initial orientation to the program curriculum, adult learning theory, and current content specific pedagogical and instructional practices, as well as to effective supervision approaches such as cognitive coaching. To facilitate district-employed supervisors meeting program expectations, the program ensures that district-employed supervisors remain current in the knowledge and skills necessary for effective candidate supervision.
22. Should an Intern or Student Teacher subject to this MOU fail to adhere to any of the above expectations, District will work with the University attempt to reach a mutually acceptable outcome. If a mutually acceptable outcome cannot be reached between District and the University, District reserves the right to release any Intern or Student Teacher.
23. If the District finds that an Intern performs below standards acceptable to the District, after appropriate support and advice have been exhausted and is removed from the paid Intern position by the District, the District is to provide immediate written notification to the University.

#### INSURANCE

Alliant International University, Inc. shall maintain commercial general liability insurance from an insurance carrier with an AM Best rating of A- VII or better in the minimum amounts of \$1,000,000 per occurrence, \$3,000,000 general aggregate, and shall furnish proof thereof in the form of a certificate of insurance within 30 days of the effective date of this Memorandum of Understanding. Further, University agrees to maintain sexual misconduct liability insurance, at \$2,000,000 for each victim, and \$4,000,000 for each policy year.

The District shall provide and maintain commercial general liability insurance acceptable to Alliant International University, Inc., or utilize a program of self-insurance in the minimum amounts of \$1,000,000 combined single limit,

\$3,000,000 general aggregate, and upon request shall furnish proof thereof in the form of a certificate of insurance within 30 days of the effective date of this Memorandum of Understanding.

The parties understand and agree that Interns are not employees, contractors or agents of the parties. Interns are students of the University. It is understood and agreed that the University's students are not to be considered employees of the District and therefore students are not eligible for worker's compensation insurance under the District but that the University does maintain worker's compensation insurance for student coverage.

#### NON-DISCRIMINATION, HARASSMENT, RETALIATION CLAUSE

The University and the District agree to abide by the requirements of all federal and state laws regarding prohibited discrimination, harassment, and retaliation, as well as equal opportunity, including, but not limited to: Titles VI and VII of the Civil Rights Act of 1964, as amended by the Equal Employment Opportunity Act of 1972, Federal Executive Order 11246, as amended, the Rehabilitation Act of 1973, as amended, the Vietnam Era Veteran's Readjustment Assistance Act of 1974, Title IX of the Education Amendments of 1972, the Age Discrimination in Employment Act of 1975, the Americans with Disabilities Act of 1990, the Equal Pay Act, the Fair Employment & Housing Act of 1968, as amended, the California Unruh Civil Rights Act, the California Fair Pay Act, and the California Fair Employment & Housing Act of 1959, as amended.

The University and the District agree not to discriminate in their enrollment and employment practices, and will render services under this Memorandum of Understanding without regard to an individual's age, race, color, religion, creed, sex (including pregnancy, childbirth, breastfeeding, and related medical conditions), sexual orientation, gender, gender expression, gender identification, national origin, ancestry, genetic information, military or veteran status, political affiliation, disabilities, or any other legally protected status. The University and the District will not permit harassment against individuals based on any of the aforementioned characteristics, nor will they permit retaliation against any individual who makes a good faith complaint regarding discrimination or harassment. Any act of discrimination, harassment, or retaliation committed by the University or the District or failure to comply with these statutory obligations when applicable shall be grounds for termination of this Memorandum of Understanding.

#### MUTUAL HOLD HARMLESS AND INDEMNIFICATION; LIMITATION OF LIABILITY; STUDENT STATUS

The University shall hold harmless, defend and indemnify the District and its officers, employees, and agents from and against any and all losses, demands, claims, damages (including costs and attorneys' fees), or causes of action arising from any negligent act or omission or willful misconduct of the University, its officers, employees, or student teachers, incurred in the performance of this Memorandum of Understanding, but only in proportion in and to the extent that such liability, loss, expense, attorneys' fees or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of the University, its officers, employees and agents.

The District shall hold harmless, defend and indemnify the University and its officers, employees, and agents from and against any and all losses, demands, claims, damages (including costs and attorneys' fees), or causes of action arising from any negligent act or omission or willful misconduct of the District, its officers, employees, or agents, incurred in the performance of this Memorandum of Understanding, but only in proportion in and to the extent that such liability, loss, expense, attorneys' fees or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of the District, its officers, employees and agents.

Except for the indemnifying party's obligations pursuant to the immediately preceding two paragraphs or the other party's gross negligence or willful misconduct: (i) neither party shall be liable to the other party for any special, incidental, consequential, indirect or punitive damages (including loss of (anticipated) profits), and/or reasonable attorneys' fees and costs, arising in any way out of this Memorandum of Understanding, however caused and on any theory of liability.

Subject to the first two paragraphs of this section, a party shall have no liability to the other party for any loss suffered which arises out of any action or inaction if, in good faith, it is determined that such course of conduct was

in the best interests of the parties involved and such course of conduct did not constitute gross negligence or intentional misconduct.

The parties to this Memorandum of Understanding hereby assert that no liability is assumed by either party for damages or injuries which arise from participants independently traveling to or from service sites.

The parties understand and agree that Interns are not employees, contractors or agents of the parties. Interns are students of the University. It is understood and agreed that the University's students are not to be considered employees of the District and therefore students are not eligible for worker's compensation insurance under the District but that the University does maintain worker's compensation insurance for student coverage.

The parties to this Memorandum of Understanding also agree that each is responsible only for the actions of their respective officers, agents, and employees. Neither party hereto is to be considered the agent of the other party for any purpose whatsoever, and neither party has any authority to enter into any contract or assume any obligation for the other party or to make any warranty or representation on behalf of the other party.

### **CONFIDENTIALITY**

The parties acknowledge that many student educational records are protected by the Family Educational Rights and Privacy Act, 20 U.S.C. § 1232g; 34 C.F.R. Part 99, as amended ("FERPA"), and that the permission of students must be obtained before student data can be released to anyone.

The parties' mutual understanding on the treatment of Confidential Information (as defined below) is as follows:

1. The District and the University shall not, and shall not permit any of their respective employees, agents or contractors, to use, reproduce, distribute, publish, disclose, transmit or otherwise transfer, directly or indirectly, to any other person, organization or entity, any Confidential Information of the other party (or any portion thereof), except (i) to the extent necessary to perform its obligations to the other party in connection with this Memorandum of Understanding; or (ii) with the prior written permission of the other party. Each party agrees to disclose the Confidential Information of the other party solely to those of its employees, agents and contractors having a good faith need to know such information. Each party shall protect the Confidential Information of the other party by exercising at least the same measures that such party uses to protect its own confidential information of like character, which shall be no less than a reasonable standard of care. Each party shall be held responsible for any and all breaches of this paragraph by or through any employee, agent or contractor of such party. Each party shall (x) inform all employees, agents and contractors having access to any or all of the Confidential Information of the other party of the existence of this Memorandum of Understanding and the confidentiality obligations set forth herein; and (y) take sufficient steps to cause such employees, agents and contractors to observe the confidentiality obligations set forth herein. If either party or one of their employees, agents or contractors is compelled (by deposition, interrogatory, request for documents, subpoena, civil investigation demand or similar process) to disclose any of the Confidential Information of the other party, that party shall provide the other party with prompt prior written notice of such compulsion so that the other party may seek, at its own expense, a protective order or other appropriate remedy or, if appropriate, waive compliance with the terms of this Memorandum of Understanding.
2. As used herein, "Confidential Information" means all confidential information in documents or other tangible materials clearly marked as proprietary or confidential about, or disclosed by, either party to this Memorandum of Understanding, including knowledge, technical and business information relating to such party's products, research and development, production, costs, engineering processes, artwork, designs, computer software, formulas, methods, ideas, concepts, contemplated new services, improvements, associations with other organizations, profit or margin information, finances, customers, suppliers, marketing, and past, present or future business plans and business arrangements, and information concerning employees (including, in the case of the University and the District, faculty), Interns, and

students or prospective students (provided any disclosure relating to any student or prospective student is permitted by and carried out in accordance with FERPA). Notwithstanding the foregoing, no information shall be deemed Confidential Information if such information: (i) is generally known to the public on the date of disclosure of same or becomes generally known to the public after such date through no breach of this Memorandum of Understanding or any other obligation of confidentiality; (ii) was known by the party receiving such information under this Memorandum of Understanding (the "Receiving Party") without any obligation to hold it in confidence at the time of disclosure; (iii) is received by the Receiving Party after the date of disclosure by the other party (the "Disclosing Party") hereunder from a third party without imposition, knowledge or breach of any obligation of confidentiality; (iv) is independently developed by the Receiving Party after the date of disclosure by the Receiving Party without access to Confidential Information of the Disclosing Party; or (v) is approved for release by written authorization of the Disclosing Party.

3. The District and the University acknowledge that the University's use of the internship programs may be subject to the privacy regulations outlined in FERPA, for the handling of such information. The District shall not knowingly disclose Confidential Information to any third party in violation of FERPA. The District represents and warrants that it will comply with FERPA to the extent applicable and will instruct its employees handling Intern student information provided by the University of its obligations under FERPA. The District further agrees that it will prohibit its employees from accessing any records of any student or prospective students at the University, including Interns, without a valid business reason to access such records.

#### **GENERAL TERMS**

This Memorandum of Understanding contains all of the terms and conditions between the parties. This Memorandum of Understanding may be revised or modified only by mutual agreement and written amendment signed by both parties.

Each party represents and warrants to the other party that: (i) it has all requisite power and authority to execute this Memorandum of Understanding and to perform its obligations hereunder; (ii) the execution, delivery and performance of this Memorandum of Understanding have been duly authorized and approved by each party, and will not conflict with any agreement of, or law applicable to, such party; (iii) this Memorandum of Understanding is a valid and binding agreement of each party enforceable in accordance with its terms.

In addition to its representations in the immediately preceding paragraph, the District represents and warrants to the University that:

1. it is and will continue to be in compliance all applicable federal, state, and local laws, including without limitation all privacy, data protection, advertising and marketing laws, and contracts;
2. neither it nor any of its affiliates has been debarred or suspended, or engaged in any activity that is cause for debarment or suspension, pursuant to applicable state law; and
3. it shall take any and all actions, or refrain from or cease such actions, as is necessary to maintain the University's reputation, accreditation, state approvals, Title IV eligibility, and academic integrity, including, but not limited to, adherence with the U.S. Department of Education's misrepresentation regulations provided at 34 C.F.R. Part 668 Subpart F.

Neither party may, without written approval of the other, assign this Memorandum of Understanding or transfer its interest or any part thereof under this Memorandum of Understanding to any third party, except that a party may assign its rights or obligations to a third party in connection with the merger, reorganization or acquisition of stock or assets affecting all or substantially all of the properties or assets of the assigning party.

This Memorandum of Understanding constitutes the entire understanding and agreement among the parties hereto with respect to the subject matter hereof, and there are no agreements, understandings, restrictions or warranties among the parties other than those set forth herein provided for.

If any of the sections of this Memorandum of Understanding shall be deemed invalid, void, or for any reason unenforceable, that section shall be deemed severable and shall not affect the validity and enforceability of any remaining section.

Except for ancillary measures in aid of arbitration and for proceedings to obtain provisional or equitable remedies and interim relief, including, without limitation, injunctive relief, any controversy, dispute or claim arising out of or in connection with or relating to this Memorandum of Understanding, or the breach, termination or validity thereof or any transaction contemplated hereby (any such controversy, dispute or claim being referred to as a "Dispute"), shall be finally settled by arbitration administered by Judicial Arbitration & Mediation Services, Inc. ("JAMS"), pursuant to its Comprehensive Arbitration Rules & Procedures (the "JAMS Rules"). The parties understand and agree that, by signing this Agreement, they are expressly waiving, to the fullest extent permitted by law, any and all rights to a trial before a judge or jury or hearing before an adjudicative agency, regarding any disputes and claims which they now have or which they may in the future have that are subject to arbitration under this Agreement. There shall be one neutral arbitrator that shall be mutually agreed to by the parties or, if the parties do not agree, then one shall be appointed pursuant to JAMS's procedures, in each case, within 30 business days of receipt of the demand for arbitration by the respondent(s) in any such proceeding. An arbitration pursuant to this paragraph shall take place in San Diego, California. A final award shall be rendered as soon as reasonably possible. The Arbitrator shall permit both parties to engage in reasonable pre-hearing discovery to obtain information to prosecute or defend the asserted claims. The arbitration decision or award shall be in writing. The arbitrator shall have the authority to award any relief authorized by law in connection with the asserted claims or disputes. Judgment on the decision or award rendered by the arbitrator may be entered and specifically enforced in any court having jurisdiction thereof. All arbitrations commenced pursuant to this Memorandum of Understanding, or any other related agreement or document, shall be consolidated and heard by the initially appointed arbitrator. The arbitration award or ruling shall provide for payment by the losing party of the fees and costs of the arbitration, including without limitation, the reasonable attorneys' fees and attorneys' costs incurred by the prevailing parties.

This Memorandum of Understanding, and any controversy arising out of or relating to this Memorandum of Understanding, shall be governed by and construed in accordance with the internal laws of the State of California, without regard to conflict of law principles that would result in the application of any law other than the law of the State of California.

This Memorandum of Understanding may be executed and delivered by email signature and in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument and each of which may be executed by less than all parties, each of which shall be enforceable against the parties actually executing such counterparts, and all of which together shall constitute one instrument.

The titles and subtitles used in this Memorandum of Understanding are used for convenience only and are not to be considered in construing or interpreting this Memorandum of Understanding.

All notices and other communications given or made pursuant to this Memorandum of Understanding shall be in writing and shall be deemed effectively given: (a) upon personal delivery to the party to be notified, (b) when sent by confirmed facsimile if sent during normal business hours of the recipient, and if not so confirmed, then on the next business day, (c) five (5) days after having been sent by registered or certified mail, return receipt requested, postage prepaid, or (d) one (1) business day after deposit with a nationally recognized overnight courier, specifying next business day delivery, with written verification of receipt. All communications shall be sent to the respective parties at their address as set forth on the signature page hereto, or to such facsimile number or address as subsequently modified by written notice given in accordance with this paragraph.

The Sections titled "Non-Discrimination, Harassment, and Retaliation Clause," "Mutual Hold Harmless and Indemnification; Limitation of Liability; Student Status," "Confidentiality," and "General Terms" shall survive the termination of this Memorandum of Understanding.

The obligations of the parties to this MOU are subject to prevention by causes beyond the parties' control that could not be avoided by the exercise of due care, including, but not limited to, natural disasters, riots, wars, epidemics, pandemics, or any other similar cause.

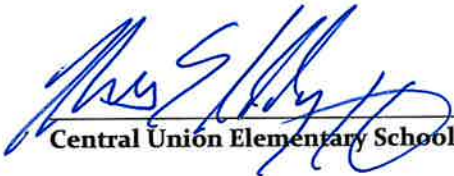

- 8) The SARB staff will prepare the necessary documents when the County SARB approves a referral for a criminal complaint and file with the appropriate law enforcement agency, and
- 9) The SARB staff will maintain, facilitate and host the Truancy Intervention Prevention Program (TIPP) at a KCOE approved facility.

2. Through this written agreement, the Lead District is assigned control of the Participant District’s fair share of USDA Foods entitlement for SY2024-25. The Lead District is responsible for ordering, receiving, storing, and distribution of Direct Delivery USDA Foods on behalf of Participant.
3. Lead District is responsible to maintain an inventory management system for all USDA Foods Direct Delivery items received and stored on behalf of Participant. Participant is responsible to maintain an inventory management system for all USDA Foods Direct Delivery or processed items after delivery to Participant District.
4. Both parties are responsible for compliance with USDA and the CDE, Nutrition Services Division policies and regulations.
5. SY2024-2 Fees:  
 Membership Fees are paid by Participant District directly to the Lead District, billed in July 2024.  
 Annual Renewal Fee beginning the 2nd year of membership shall be 0.3% of the current year USDA Foods estimated entitlement on July 1.  
 State Administrative Fee of \$0.90 per case/unit of USDA Foods direct delivery (brown box) and diverted to processors.  
 Delivery fees as per member district selected distributors.  
 All fees are subject to change, as approved by the Super Co-Op JPA Board of Directors.

13. In the event of a change in Lead District, this Agreement shall convey to the new Lead District.
14. Termination of the Assignment of USDA Foods shall be made in writing to the Lead District no later than December 10 to take effect the following June 30.

# CONSULTING SERVICES AGREEMENT

This Agreement is entered into effective the 1st day of April, 2024 by and between Total Compensation Systems, Inc. Termination of this agreement shall not relieve either party of any rights or obligations arising out of the Agreement prior to termination, with the exception that the amount of the final payment that shall be made by Customer shall be based solely upon the percentage of work that was completed by Consultant.
4. Customer Will Provide Information. Customer shall provide Consultant with the information necessary for Consultant to provide the consulting services described on Schedule 1 attached hereto.
5. Authorization to Acquire Information. Customer hereby authorizes Consultant to acquire the necessary information reasonably required by Consultant to provide the consulting services described on Schedule 1 attached hereto from any agency, agencies, source or sources.
6. Customer's Right to Provide Information. Customer represents and warrants to Consultant that it has the right to provide the information that will be given by Customer to Consultant, or which will be acquired by Consultant pursuant to paragraphs 4 and 5 above.
7. Limitation on Services. Customer understands that Customer retains sole authority and responsibility for the operation and design of all Customer's employee benefit plans.
8. Ownership of Systems and Materials. All systems, programs, operating instructions, forms and other documentation prepared by or for Consultant shall be and remain the property of Consultant. All data source documents provided by Customer shall remain the property of Customer.
9. Indemnification. (a) By Customer. Customer hereby agrees to defend and indemnify Consultant and hold Consultant harmless against any claims, injury, costs or damages (including actual attorneys' fees incurred) resulting from Customer's gross negligence or willful misconduct. (b) By Consultant. Consultant hereby agrees to defend and indemnify Customer and hold Customer harmless against any claims, injury, costs or damages (including actual attorneys' fees incurred) resulting from Consultant's gross negligence or willful misconduct.


10. General.

- a. Relationship of the Parties. The relationship between Consultant and Customer established by this Agreement is that of independent contractors. Consultant and Customer shall each conduct its respective business at its own initiative, responsibility, and expense, and shall have no authority to incur any obligations on behalf of the other.
- b. Force Majeure. No party shall have liability for damages or non-performance under this Agreement due to fire, explosion, strikes or labor disputes, water, acts of God, war, civil disturbances, acts of civil or military authorities or the public enemy, transportation, facilities, labor, fuel or energy shortages, or other causes beyond that party's control.
- c. Entire Agreement. This Agreement and the Schedules attached hereto contain the entire agreement between the parties and supersedes all previous agreements and proposals, oral or written, and all negotiations, conversations, or discussions between the parties related to the subject matter of this Agreement. This Agreement shall not be deemed or construed to be modified, amended, rescinded, canceled or waived in whole or in part, except by written amendment signed by both of the parties hereto.


11. Confidentiality. Consultant recognizes that its work will bring it into close contact with confidential information of Customer, including personal information about employees of Customer. Consultant agrees not to disclose anything that is the confidential information of Customer, or that is proprietary to Customer, including its software, its legacy applications, and its databases, to any third party.

## SCHEDULE 1

For the purposes of this Agreement, "consulting services" shall include the following services provided by Consultant to Customer:

Consulting reports including all actuarial information necessary for Customer to comply with the requirements of current GASB accounting standards 74/75 related to retiree health benefits for two years, including one full valuation and one "roll-forward" valuation. Study results can be split by up to four employee classifications. Consultant will provide as many copies of the final reports as Customer shall reasonably request.

Services do not include Consultant's in-person attendance at any meetings. Services also do not include a separate funding valuation unless requested by Customer.

## SCHEDULE 2

Customer shall pay Consultant for the retiree health valuation report based on the full valuation a total of \$7,000. One-half, or \$3,500 shall be due within 30 days of the commencement of work by Consultant. One-half, or \$3,500 shall be due within 30 days of the delivery by Consultant to Customer of the draft consulting report for the full valuation (or within 30 days of contract termination, if earlier). Customer shall also pay Consultant for the retiree valuation report based on the “roll-forward” valuation a total of \$3,500 within 30 days of the delivery by Consultant to Customer of the draft consulting report for the “roll-forward” valuation (or within 30 days of contract termination, if earlier)

If Consultant receives a non-refundable deposit from Customer of \$3,150 by May 31, 2024, all amounts shown above shall be reduced by 10%.

This letter is our proposal for continued GASB 74/75 actuarial valuation services. The proposal includes a full actuarial valuation as of June 30, 2024 as well as an anticipated roll-forward valuation as of June 30, 2025.

## Fees and Our 10% Discount

To confidently schedule existing clients, we provide an incentive for clients who make a commitment in advance of the valuation date. To reserve a place in our schedule, please send the signed contract and non-refundable deposit of one-half of the full valuation fee by May 31, 2024. By reserving a spot, Central Union School District is guaranteed a valuation slot and is prioritized over our other clients that didn't reserve one.

We apply a 10% discount to the full valuation fee as well as to the subsequent roll-forward valuation fee for those who reserve a spot by May 31, 2024. This means that, to reserve a spot, we must receive the signed contract and a check for \$3,150 (one half of the \$6,300 shown below) by May 31, 2024. The following table shows our fees for the GASB 74/75 valuations:

## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The LEA used a process to involve stakeholders (parents, teachers, and school staff) in the development of the Expanded Learning Opportunities (ELO) Grant Plan and identification of support strategies that will be implemented. Throughout the school year, stakeholders were provided updates on student academic, social, and behavioral needs. These stakeholder groups included School Site Council (SSC), District Advisory Council (DAC), Indian Education Council (IEC), and English Language Advisory Council (ELAC). During scheduled meetings, members reviewed, discussed, and provided feedback on addressing learning loss needs. Teachers provided additional input through feedback in collaboration meetings, MOU planning meetings, and communications with site and district administrators. The need to provide an expanded learning program beyond the school year was a request by many stakeholder.

A description of how students will be identified and the needs of students will be assessed.

The District's plan includes identifying students in need of academic, social-emotional, and other integrated student supports. A Multi-Tiered System of Supports is being implemented at all sites. Students will be identified at the site level. Academic data from the Districtwide screener, iReady in reading and mathematics identifies students in need and provides information on the specific needs of students. This adaptive assessment is administered 3 times per year. iReady Assessments are also available for progress monitoring of students on a regular basis. Data from formative assessments aligned to grade level Essential Standards and teacher input assist in identification and needs. Social-emotional needs and students in need are determined based on data compiled by district counselors, SEL screener data, and teacher recommendations. Other integrated student supports (health, counseling, mental health services, school meal programs) are available to students to address barriers to learning. These services may be coordinated through the Student Study Team (SST) process. Initially, the district started using iReady during the 2021 school year for interventions. We transitioned to using iReady across the district for all grades k-8 during the 2022-2023 school year.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and guardians of students identified as needing supplemental instruction and support will be contacted personally. Site staff will communicate the student's need and the opportunities available. Program offerings will be provided to parents/guardians, will outline the expectations, and give information of the criteria that determined how their child would benefit from this program. This information will be provided in the parents'/guardians' primary language of English or Spanish.

A description of the LEA's plan to provide supplemental instruction and support.

A Multi-Tiered System of Supports is being implemented at all sites. Supplemental instruction and support will be provided in a tiered framework that bases universal, targeted, and intensive supports on students' needs for academic, social-emotional, and other integrated student supports. Professional Learning Communities (PLCs) are utilized at the district and site level. This data driven process includes addressing the needs of all students and closing the gaps for our high risk students (low-income, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level)

The Districtwide academic screener assessments are administered to all students. Differentiation strategies utilized in Tier 1 instruction provide core instruction to all students with supports as needed. Targeted supports are provided as a component of sites' MTSS/RTI systems. Targeted Intervention (Tier 2) focused on providing supports leading to the success of students meeting grade level Essential Standards are included in the school day. Teams have developed identification criteria and are developing clear exit criteria. Additional academic services for identified students, such as progress monitoring (Strategy 6) will be leveraged to monitor progress of students and effectiveness of supports. Due to learning loss resulting from COVID19, more significant numbers of students are in need of such supports as well as more intensive supports due to larger gaps. Expanded Learning Opportunities will be provided to extend instructional learning time (Strategy 1). Each site will offer an Expanded Learning Opportunity this summer from June 7 to June 25, 2021 addressing students' academic needs. This opportunity includes both pre- and post-testing to monitor student progress and program effectiveness. Supplemental support needs will continue to be evaluated on an ongoing basis. Additional expanded learning opportunities (after school, Saturday options, and intersession options) will be offered based on student needs. Expanded learning opportunities will focus on Tier 2 (grade level) and/or Tier 3 (previous grade level(s) needs of students as determined by sites. The District is planning to purchase materials to be used in intensive Tier 3 academic intervention (Strategy 2b - learning recover programs and materials). It is exploring the purchase of a comprehensive

assessment and instruction program that empowers educators with the resources they need to help students succeed . The online adaptive program would be combined with direct teacher instruction to reach students one to two years behind grade level through the 2021-22 school year. Staff will be provided additional training (Strategy 7) as needed to address students' academic needs.

Integrated student supports to address barriers to learning (Strategy 3), such as health, counseling, and access to meal programs are provided throughout the school year. The District will include integrated supports in expanded learning opportunities as appropriate and based on students' identified needs.

Support for social and emotional well-being and positive school climates has never been more crucial. A districtwide SEL Screener is taken twice a year. Data informs staff of site trends and student needs. Social Emotional Learning (SEL) Tier 1 lessons are delivered in classrooms based on the needs of students. Counselors (Strategy 3) support sites and teachers in meeting student needs. Based on data from surveying parents & staff of student needs, counselors plan topics and provide guidance to site leadership teams in determining the focus for their site. The Student Services Coordinator and counselors will attend training (Strategy 7) on trauma-informed practices, to engage students and families in addressing students' social emotional health needs. The team will then share strategies and support staff during school year.

Student nutrition (Strategy 3) impacts student learning. All students have access to meal program through June 2021. Breakfast and community meal offerings are available through the 3 weeks of the summer expanded learning opportunity. In 21-22 the state will be returning to the National School Lunch Program (NSLP). The District is investigating becoming a Free & Reduced District for all students (CEP) to expand access to healthy nutrition to all students.

The District looks at the coordination of funds on an on-going basis to best meet the needs of students. ELO Grant funds are being utilized to provide needed expanded learning opportunities and inclusion of integrated services in those opportunities as appropriate. The ESSER funds will provide for PPE and sanitation and facilities needs to allow for social distancing for those expanded learning opportunities. Based current needs, the district anticipates the need for expanded learning opportunities beyond the ELO Grant. ESSER funds will help support any extensions of those opportunities as the district continues to address learning loss, in-person learning, facilities, and increased social and emotional health student needs.

7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

**Item:**

A New food and dry storage warehouse purchase for the Nutrition Services department. The new warehouse is 20x40.

**Rationale/Purpose:**

The new warehouse storage unit will replace the current 8x40, C Train. This storage is used by the Nutrition Department to store commodities food and paper supplies.

**Fiscal Impact:**

This new warehouse will be purchased with the KIT funding the Nutrition Services department was granted. The cost of the new unit is \$14,096.08

**Recommendation:**

Recommend that the purchase of this unit be approved.

## TERMS AND CONDITIONS

### 1. Prices, Payment and Risk of Loss.

(a) Central Valley Steel Structures, LLC (“CVSS”) reserves the right to update or change any pricing discrepancies made by any sales representative.

(b) Prices contained in CVSS’ published price lists or quotes, if any, are subject to change without notice. Prices in individual quotations or proposals are firm only for a period of twenty (20) days from the date of the quotation after which the customer should inquire of CVSS as to their validity and request a written confirmation or revision. Prices quoted do not include taxes. Customer agrees to pay all applicable sales or other taxes levied with respect to any goods and replacements, unless exempt therefrom. All prices are in United States dollars. Customer shall pay all government fees levied on the installation and inspection of any goods sold by CVSS.

(c) CVSS may unilaterally increase prices to cover increased costs (plus reasonable overhead and profit) of design, materials, and manufacturing required by changes requested by the customer after the date of any quotation.

(d) Customer expressly agrees that the steel structure shall remain the property of CVSS until full and final payment is made.

(e) CVSS hereby retains a purchase money security interest in the steel structure as set forth in Section 9 of the Uniform Commercial Code (“UCC”) as enacted in the state where the steel structure is being installed. Failure by the customer to pay for the steel structure will result in repossession of the steel structure. In the event of a repossession, it shall not relieve the customer from liability for specific performance of the contract including legal fees and court costs. As collateral security for the payment of the purchase price of the steel structure, customer hereby grants to CVSS a lien on and security interest in and to all of the right, title and interest of customer in, to and under the steel structure, wherever located, and whether now existing or hereafter arising or acquired from time to time, and in all accessions thereto and replacements or modifications thereof, as well as all proceeds (including insurance proceeds) of the foregoing. The security interest granted under this provision constitutes a purchase money security interest under the California Uniform Commercial Code.

(f) All balances are to be paid in full at the time of installation of the steel structure by cashiers-check, money order, credit card, or cash. No personal checks or company checks are accepted. Any amounts not paid when due will bear interest until paid at a rate equal to 18% annually or the maximum allowed by law, whichever is less.

(g) CVSS reserves the right to cancel any order at any time.

(h) In the event the customer cancels the order, for any reason or at any time, customer shall not receive a refund of any portion of any amounts paid, including but not limited to the down payment, and shall be responsible for any and all costs incurred by

CVSS up until the date of cancellation plus CVSS' anticipated profit that it would have received had the order not been cancelled by the customer.

(i) CVSS will not issue any refunds on any special orders, for any reason.

(j) In the event the customer makes a larger initial deposit than required, the customer does so at customer's own risk with the understanding that no portion of any deposit is refundable in the event the contract is cancelled.

(k) Customer has twelve (12) months from the date the steel structure is ordered to obtain all necessary permits, level the ground where the installation is to take place, and complete all requirements of the customer pursuant to this Agreement. In the event the customer fails to do so, this Agreement shall be automatically cancelled by CVSS unless this Agreement is modified by CVSS and the customer in writing.

## 2. Delivery and Installation.

(a) Customer shall be solely responsible to obtain any and all required city or county permits prior to commencement of installation. CVSS is not liable for any county or city ordinance or county violations.

(b) The location where the customer desires the steel structure to be installed must be leveled by the customer (at the customer's sole cost) prior to the installation or the installation will be postponed and return trip fees will apply.

(c) Customer is responsible for obtaining local permits, covenant searches, and right of way or setback restrictions. Customer will inform CVSS of any underground cables, gas lines, hazards, or any other utility lines. This may include contacting the utility company to request that the locations of the underground utilities be marked. CVSS is not responsible for any damage caused to underground utilities. Customer agrees to indemnify and hold harmless CVSS from any and all liability and costs, including attorney fees, for such damage.

(d) Installation dates are estimated based on CVSS' present backlog of orders and scheduling and may be revised by CVSS upon notice to customer. All installation dates are approximate. Installation dates may be rescheduled at CVSS' sole discretion due to bad weather, supply chain issues, mechanical issues, accidents, etc.

(e) If the customer requests that the installation be made on a site which has not been leveled, or if there is not at least two (2) feet of clearance completely around the installation site, the steel structure will be installed "as-is" and all warranties will be void. In addition, CVSS shall not be responsible for immediate or subsequent damage to persons or property.

(f) The site of the installation must be at least ten (10) feet away from any electrical wires or poles.

(g) All steel structures are secured with anchors which pass through the base rail of the frame and into the ground. As the base rail is only affixed to the ground with anchors, customer understands that customer may experience water leakage underneath the base rail.

(h) Uncertified units are anchored at every other post by rebar or concrete anchors. Additional anchors may be purchased at an additional cost to the customer. Rebar anchors are 32" long but may be shortened when installing on difficult terrain. Mobile home or post anchors are also available for uncertified units at an additional cost to the customer. There will be an additional charge to the customer for mobile home or post anchors placed on asphalt.

(i) Certified units are anchored at every post and mobile home anchors must be purchased by the customer for ground installations and concrete anchors for cement installation. There will be an additional charge to the customer for installation of mobile home or post anchors placed on asphalt.

### 3. Warranties.

(a) Standard (Uncertified) Units: These units are built according to CVSS' specifications and industry standards. Uncertified units are not eligible for snow load or wind ratings. All uncertified units come with a 30-day limited warranty which includes manufacturers and/or installation defects.

(b) Standard 14 Gauge Unit: These units are constructed with 2 ½" pre-galvanized square tubing that does not carry a rust through the framing warranty. 30-day manufacturers limited warranty does apply.

(c) Standard 12 Gauge Unit: These units are constructed with a 2 ¼" pre-galvanized square tubing which provides higher tinsel strength and thickness of material. These units come with an additional 10-year warranty on rust through the framing.

(d) Certified Units: These units are available in twelve and fourteen gauge and are backed by an engineer approved blueprint that is available to the customer for purchase of an additional cost. These structures are wind and snow rated for compliance with local code and state regulations. These units are covered by a 5-year limited warranty in accordance with the customer's engineered blueprints.

(e) In the event the customer alters the steel structure in any manner whatsoever, including any interior and/or exterior modifications, all warranties shall be immediately void.

(f) If the customer chooses to run electrical or plumbing to the steel structure, all such work must be performed by a licensed, insured and bonded contractor or all warranties shall be immediately void.

**(g) EXCEPT FOR THE WARRANTIES SET FORTH IN THIS SECTION, CVSS MAKES NO WARRANTY WHATSOEVER WITH RESPECT**



**TO THE STEEL STRUCTURE, INCLUDING ANY (a) WARRANTY OF MERCHANTABILITY; (b) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; OR (c) WARRANTY OF TITLE WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE.**

**(h) CVSS MAKES NO REPRESENTATIONS OR WARRANTIES WITH RESPECT TO ANY THIRD PARTY PRODUCT, INCLUDING ANY (a) WARRANTY OF MERCHANTABILITY; (b) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; (c) WARRANTY OF TITLE; OR (d) WARRANTY AGAINST INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS OF A THIRD PARTY; WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE.**

(i) CVSS shall not be liable for a breach of the warranty set forth in this section unless: (i) customer gives written notice of the defect, reasonably described, to CVSS within five (5) days of the time when customer discovers or ought to have discovered the defect; (ii) CVSS is given a reasonable opportunity after receiving the notice to examine such defect and; and (iii) CVSS reasonably verifies customer's claim that the steel structure is defective.

(j) All warranties provided under this Agreement extend only to the original customer. Said warranties do not extend to transferee owners of the steel structure.

4. Limitation of Liability.

**(a) IN NO EVENT SHALL CVSS BE LIABLE TO CUSTOMER OR ANY THIRD PARTY FOR ANY LOSS OF USE, REVENUE OR PROFIT, OR FOR ANY CONSEQUENTIAL, INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES WHETHER ARISING OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT CVSS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND NOTWITHSTANDING THE FAILURE OF ANY AGREED OR OTHER REMEDY OF ITS ESSENTIAL PURPOSE.**

**(b) IN NO EVENT SHALL CVSS' AGGREGATE LIABILITY ARISING OUT OF OR RELATED TO THIS AGREEMENT, WHETHER ARISING OUT OF OR RELATED TO BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, EXCEED THE TOTAL OF THE AMOUNTS PAID TO CVSS FOR THE STEEL STRUCTURE OR ITS INSTALLATION SOLD HEREUNDER.**

5. Waiver. No waiver by CVSS of any of the provisions of this Agreement is effective unless explicitly set forth in writing and signed by CVSS. No failure to exercise, or

delay in exercising, any right, remedy, power or privilege arising from this Agreement operates, or may be construed, as a waiver thereof. No single or partial exercise of any right, remedy, power or privilege hereunder precludes any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

6. Confidential Information. All non-public, confidential or proprietary information of CVSS, including but not limited to specifications, samples, patterns, designs, plans, drawings, documents, data, business operations, customer lists, pricing, discounts or rebates, disclosed by CVSS to customer, whether disclosed orally or disclosed or accessed in written, electronic or other form or media, and whether or not marked, designated or otherwise identified as "confidential" in connection with this Agreement is confidential, solely for the use of performing this Agreement and may not be disclosed or copied unless authorized in advance by CVSS in writing. Upon CVSS' request, customer shall promptly return all documents and other materials received from CVSS. CVSS shall be entitled to injunctive relief for any violation of this Section. Any purported assignment or delegation in violation of this Section is null and void. No assignment or delegation relieves customer of any of its obligations under this Agreement.

8. Attorney's Fees and Costs. The Parties agree that they shall bear their own respective costs and fees, including attorneys' fees, in connection with the negotiation and execution of this Agreement. The prevailing party, or parties, in any action or proceeding to interpret or enforce this Agreement, or any of its terms, shall be entitled, in addition to any judgment or award upon such action or proceeding, to an award for all costs and expenses (including costs of all legal or administrative proceedings or hearings) incurred by such prevailing party or parties, including, without limitation, all attorneys' fees and related costs incurred by such party in connection with such actions and proceedings and the enforcement of any such judgment or award and upon prevailing in any appeal relating thereto.

9. Relationship of the Parties. The relationship between the parties is that of independent contractors. Nothing contained in this Agreement shall be construed as creating any agency, partnership, joint venture or other form of joint enterprise, employment or fiduciary relationship between the parties, and neither party shall have authority to contract for or bind the other party in any manner whatsoever.

This Agreement is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other person or entity any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of these Terms.

11. Governing Law. All matters arising out of or relating to this Agreement is governed by and construed in accordance with the internal laws of the State of California without giving effect to any choice or conflict of law provision or rule (whether of the State of California

or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than those of the State of California.

12. Submission to Jurisdiction. Any legal suit, action or proceeding arising out of or relating to this Agreement shall be instituted in the federal courts of the United States of America or the courts of the State of California in each case located in the City of Fresno and County of Fresno, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding.

13. Severability. If any term or provision of this Agreement is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

14. Exclusive Agreement. CVSS and the customer agree that these Terms and Conditions constitute a complete and exclusive statement of the agreement between the parties and supersedes all prior or written or oral communications, representations, and agreements related to the subject matter of this agreement. The Terms and Conditions may only be modified by a written instrument executed by all parties except for those terms which may be altered pursuant to these Terms and Conditions without written modification.

**Item:**

Consider the increase in Adult Meal prices for the Central Union Elementary school cafeteria program.

**Rationale/Purpose:**

The California Department of Education (CDE) oversees the National School Lunch Program (NSLP), which provides funding and reimbursement for meals provided to students. One key component of the NSLP is ensuring equity and sustainability in meal pricing for both students and adults. However, recent economic changes and rising food costs necessitate a review of adult meal prices for those individuals purchasing meals through the Central Union Elementary Food Services/Cafeteria program.

From the CDE's latest update on the Management Bulletin SNP-03-2024, dated February 2024, several factors contribute to the need for adjusting adult meal prices:

1. **Cost of Ingredients:** The bulletin highlights that the cost of food items, including fruits, vegetables, grains, and proteins, has increased significantly. This rise in food prices directly impacts the overall cost of meal preparation, affecting the budget allocated for providing meals to adults.
2. **Labor and Operational Costs:** The bulletin also mentions the escalation in labor and operational costs associated with meal preparation and service. These costs include wages for cafeteria staff, equipment maintenance, and utilities. As these expenses continue to rise, maintaining the current pricing structure for adult meals becomes unsustainable.
3. **Federal Reimbursement Rates:** While federal reimbursement rates for student meals are adjusted annually to account for inflation, similar adjustments are not available for adult meals. This discrepancy creates a financial gap that needs to be addressed through a reevaluation of adult meal prices.

This adjustment aims to align the cost of adult meals more closely with the actual expenses incurred in providing them which ensures the financial sustainability of school meal programs. By increasing adult meal prices, the District can better manage rising food and operational costs while continuing to offer nutritious meals to both students and adults

Fiscal Impact:

Increase of 1.07 for breakfast and .67¢ for lunch. The new price is 4.07 for Breakfast and 5.67 for Lunch

The current price is \$3.00 for breakfast and \$5.00 for lunch.

No fiscal impact on the cafeteria, it will offset the cost of meal production for adults and the appropriate charging of costs.

Recommendation:

Accept and approve the proposed adult meal prices, to go into effect immediately upon Board ratification.

This Management Bulletin (MB) provides consolidated guidance for school food authorities (SFA) about nonprogram food requirements, revenue requirements, SFA compliance monitoring, unique situations, catering and vending requirements, and state agency monitoring through administrative review. The MB also provides policy for SFAs when using a reference period to comply with nonprogram food requirements.

## **Nonprogram Food Requirements**

Title 7 *CFR*, Section 210.14(f) defines nonprogram foods as food and beverages that are:

1. Sold at a participating school other than a reimbursable program meal; and
2. Purchased using funds from the SFA's nonprofit school food service account (otherwise known as the cafeteria fund).

SFAs shall ensure that proportion of total revenue from the sale of nonprogram foods to total revenue of the school food service account shall be equal to or greater than the proportion of total food costs associated with obtaining nonprogram foods to the total costs associated with obtaining program and nonprogram foods from the cafeteria fund. This is known as the nonprogram food revenue requirement and is explained in greater detail in the next section.

Further, 7 *CFR*, Section 210.14(f) and the National School Lunch Act specify that all revenue from the sale of nonprogram foods accrue to the cafeteria fund; and revenue available to support the production of reimbursable school meals does not subsidize the sale of nonprogram foods.

Revenue is all money provided to the cafeteria fund including, but not limited to: federal reimbursement, state or local funds, payments from children, adult meals, vended meals, catering, fund raisers, and vending machines.

Nonprogram foods are sold at any time or location and include but are not limited to the following: a la carte items, adult meals, catering, vended meals, items purchased for fund raisers, vending machines, and school stores. Some nonprogram foods can be priced below cost as long as the total revenue generated from all nonprogram food sales meets the nonprogram food revenue requirement.

## **Nonprogram Food Revenue Requirement**

SFAs are required to determine if the percent of total revenue that is generated from their nonprogram food is equal to or greater than the percent of total food costs that are attributable to the SFA's purchase of nonprogram foods. For example, if the cost of nonprogram foods is 20 percent of the SFA's total food costs, then the amount of revenue generated from the sale of the nonprogram foods must be at least 20 percent of the total revenue generated within the same reference period.


Nonprogram to program revenue requirement calculation:

*Revenue from nonprogram food divided by the total SNP and nonprogram food revenue = percent of nonprogram food revenues*

***Must be equal to or greater than***

*Food costs for nonprogram foods divided by the total food costs for SNP and nonprogram foods = percent of nonprogram food costs*

For the purpose of this calculation, the statutory requirement states that only food costs are to be used to measure compliance (i.e., exclude labor, supplies, etc.). If a nonprogram food is made from scratch, the SFA would determine the price of ingredients to calculate food cost. In addition, the food costs for catering and vending to outside agencies may be removed completely from the nonprogram food revenue requirement calculation if the SFA recovers all costs, including labor.

To assist with the calculation, the USDA created the Nonprogram Food Revenue Calculator Tool. This tool is available in the Child Nutrition Information Payment System (CNIPS) download forms, or on the USDA's website at <https://www.fns.usda.gov/cn/guidance-paid-lunch-equity-and-revenue-nonprogram-foods> . The California Department of Education (CDE) has a more detailed SNP Nonprogram Food Tool to assist SFAs further with the nonprogram food revenue requirement, which is also available in CNIPS download forms.

## **Noncompliance Due to Universal Meals Reimbursement**

The California Universal Meals Program was established in school year 2022–23, and provides additional state revenue to support the cost of providing meals for free to students attending public schools. Due to the increased state reimbursement, SFAs may find they are out of compliance with the nonprogram food revenue requirement. Please reach out to the Resource Management Unit (RMU) for assistance if your SFA is out of compliance presumed due to California Universal Meals Program reimbursement. ## **SFA Compliance Monitoring**

Under the federal nonprogram food revenue requirement, SFAs need to track the cost and sale of nonprogram foods in order to determine compliance. USDA Policy Memo SP 20-2016 states the SFA must collect the following: The total nonprogram food sales (revenue); total revenue of both program and nonprogram foods sold; itemized lists of all nonprogram foods offered and the per item/serving cost; number of items/servings sold; and total food costs for program and nonprogram foods.

SFAs should monitor compliance of nonprogram food sales at least once per year to ensure that revenues from the sales of nonprogram foods generate at least the same proportion of SFA revenues as they contribute to SFA food costs. To implement this requirement, SFAs should compile the total revenue and food costs for the entire school year and use the USDA Nonprogram Foods Calculator Tool to assess if the nonprogram food revenue requirement is met.

USDA Policy Memo SP 20-2016 clarifies that state agencies may establish the reference period for SFAs. **Therefore, the CDE allows SFAs to monitor compliance using a reference period that coincides with one menu cycle and be no less than two consecutive operational weeks** (i.e., 10 days for a 5-day week or 8 days for a 4-day week). All revenue and cost data used to assess compliance must reflect the same reference period.

A reference period is useful for SFAs to monitor compliance throughout the school year or in cases where the entire year is not reflective of the SFA's typical school year. For example, this may apply when a school recently began selling nonprogram foods or if the school was closed for a portion of the year due to disaster.

If at the end of the year or reference period, the USDA Nonprogram Foods Revenue Calculator Tool determines additional revenue is needed to comply (i.e., SFA's percent of revenue is less than their percent of cost), SFA's may adjust nonprogram foods pricing and/or deposit nonfederal funds into the cafeteria fund to offset the difference. The CDE monitors compliance with the nonprogram revenue requirement through the resource management section of the administrative review (AR) process. Please note, to assess compliance with the revenue requirement during the AR, the CDE allows for SFAs to use a reference period in the current school year only in situations where the SFA does not have complete nonprogram food information from the prior closed school year or the SFAs nonprogram food operations have significantly changed. Please see the section titled Administrative Review for more information.

### **Unique Situations**

Some SFAs may offer a limited number of nonprogram food items with an easy to identify per serving cost (e.g., the SFA only sells milk a la carte) and are not able to accurately perform the assessment. In these instances, SFAs may be charging the full cost for the nonprogram foods they offer, but due to the small number of these items in relation to the total revenue and costs, their assessment may overestimate the required increase in sales price or amount to comply.

During the AR, the CDE may determine that the compliance assessment does not fully represent the SFA's pricing practice and may instead base compliance on whether or not the SFA is recovering more than the per-serving food cost of these nonprogram items.

### **Catering and Vending Requirements**

An SFA may offer catering or vending to outside agencies (i.e., charter schools) or other departments such as the superintendent's office, the school board, student clubs, or meetings. However, the SFA may provide goods and services to the outside entity only if all costs, **including labor and any other costs incurred**, are covered by the entity being served by the school food service operations.

When catering and vending, the USDA encourages SFAs to have a written agreement that identifies costs and other responsibilities. The agreement should include a stipulation that all risk relating to revenue losses must be covered by the outside entity and not the school food service. For example, if a parent group purchases hamburgers from the school food service, but is unable to sell all of the hamburgers, the parent group is still responsible for reimbursing the food service the costs associated with the purchase and any labor that was involved in the SFA's preparation of the hamburgers.

The CDE reminds SFAs that revenue sharing agreements are not allowed. All revenues from the sale nonprogram foods within the food service must accrue to the cafeteria fund. However, once the nonprogram food is sold to the entity outside of food service, the food may be resold by the outside entity. For more information, please see USDA Policy Memo SP 13-2014 at [https://www.fns.usda.gov/resources?f%5B0%5D=program:39&f%5B1%5D=resource\\_type:160](https://www.fns.usda.gov/resources?f%5B0%5D=program:39&f%5B1%5D=resource_type:160) .

Program regulations do not restrict revenues earned from the sale of competitive foods that are purchased with funds outside of the cafeteria fund, i.e. the general fund. However, state agencies and SFAs are reminded that to the extent such foods are sold on the school campus during the school day, the "Smart Snack" requirements at 7 *CFR* 210.11 apply. Additionally, California state-specific competitive food rules also apply to public schools. For more information visit <https://www.cde.ca.gov/ls/nu/he/compfoodsrefpub.asp> for public schools and <https://www.cde.ca.gov/ls/nu/he/compfoodsrefcharter.asp> for non public charter and private schools.

## **State Agency Monitoring through AR**

Compliance with the nonprogram food revenue requirement is reviewed during the resource management portion of the AR. While noncompliance with the revenue from nonprogram foods requirements is not subject to fiscal action as defined under 7 *CFR* 210.18(m), the CDE must ensure that SFAs secure nonfederal funds to make up any shortfalls in the cafeteria fund and/or otherwise take steps to ensure that nonprogram foods are priced sufficiently to

meet the nonprogram foods requirement. The CDE may request the following documentation from SFAs to determine compliance with the nonprogram food revenue requirement:

- The USDA Nonprogram Revenue Calculator Tool
- Nonprogram food revenue and cost source documentation
- Total School Nutrition Program revenue and cost source documentation
- Comprehensive list of all nonprogram foods offered
- Adult meal cost determination and local policy
- Catering or vending invoices and documentation that support costs were recovered and deposited in the cafeteria fund

Also, as previously stated, the CDE allows for SFAs to use a reference period in the current school year only in situations where the SFA does not have complete nonprogram food information from the prior closed school year or the SFAs nonprogram food operations have significantly changed. Likewise, the CDE may determine during the AR that an SFA has a unique situation, and the revenue requirement does not fully represent the SFA's pricing practice. SFA are encouraged to reach out to the RMU to determine if a reference period or unique situation applies to their operations.

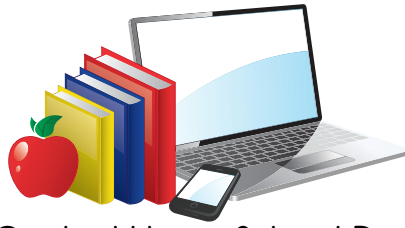

Item:

Approve the Transitional Kindergarten (TK) Instructional Aide job description and updated hourly salary schedule with the new job title.

Rationale/Purpose:

The District has TK classrooms at the Neutra and Stratford school sites, respectively. Currently, TK is for students turning five years old between September 2, 2023, through April 2, 2024. The 2024-25 school year students will be eligible for TK if they turn five between September 2, 2024, and June 2, 2025. Due to the younger age of students enrolling in the TK program, we are seeing more support being needed, specifically with assisting students with toileting, hand washing, and behavior. In the current Instructional Aide job descriptions, no duties and responsibilities are listed for toileting and hand washing. Therefore, including these duties for the TK instructional aide job description will expand the responsibilities among the adults to assist students in the restroom. Currently, this responsibility is residing solely with the school site Nurse.

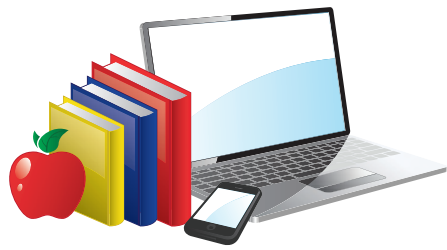
Fiscal Impact:
